It is well established today that *race* is a social construct, a social classification based on phenotype that artificially divides people into distinct groups according to certain physical characteristics. However, to a fairly great extent it still governs the distribution of risks and opportunities in our societies. Although ethnicity reflects cultural heritage, race measures a societally imposed identity and the consequent exposure to societal constraints associated with that particular identity. This allows us to situate racism from the perspective of the construction of nation-states and to analyze it not only as an ideology of difference and inequality, and not only as a form of domination and oppression between classes or ethnic groups, but also as a logic of extermination and exclusion. Ultimately, as a technology of power.

As Marta Casaús Arzú has put it, racism is the generalized and definitive valuation of differences –biological or cultural, real or imaginary– to the advantage of one group and to the detriment of the other, in order to justify an aggression and a system of domination. Racism is, thus, a historical-structural element that began with the conquest and colonization of the Americas, and was then imbued within the structure of the dominant classes, constituting a core aspect of their ideology even today. Conversely, it has shaped and triggered numerous forms of both resistance and management of the construction and representation of otherness within the groups historically marked by a process of racialization.

The 2021 Tschudi Lecture and SSLAS Workshop organized by the Latin American Center of the University of Zurich will examine not only the origins and development of racism and the idea of race in Latin America, but also their persistence today and the social struggles against them.
